### **Directions:**

#### **From 401 (London):**

Exit at Cty Rd 2/Hwy 2 (exit #238).

At the bottom of the ramp, turn right onto Cty Rd 2/Hwy 2.

We are approximately 3 miles on your right hand side, set back off the road immediately past the intersection with Muir Rd, behind Nikki's Roadhouse.

#### **From 401 (Kitchener):**

Exit at Oxford Rd 29 to Drumbo (exit 250).

Turn left off the ramp, go over the 401, and turn right at the first road, Gobles Rd.

Come down Gobles Rd to the stop sign at Hwy 2, turn right, and we are approximately 2 miles on your left.

#### **From Hwy 403 (Brantford, Niagara):**

Exit at Brant Rd 25 (exit 16), and turn right at the bottom of the ramp.

Go to the stop sign at Hwy 2, turn left, and we are approximately 3 miles on your left.
